In addition of the overall job of being an AEA representative and advocate, each site rep has a specific focus. Your organizing reps help with member recruitment and organizing member information meetings. Scheduling reps work on mitigating overages and are you master schedule liaison in the spring. Grievance reps work to make sure contract language and timelines are followed and are your primary site block schedule MOU committee member. Issues surrounding academy, collaboration, and the block schedule should go to them.

FREEDOM FOUNDATION INFORMATION

Our District, like many Districts throughout the state, received a Public Records Request for employee information from the Freedom Foundation.

The Freedom Foundation is funded by wealthy corporate foundations and groups affiliated with the Koch brothers. Their agenda is pretty clear - weaken and destroy public-sector unions. They are trying to do this by attempting to lure our own members away from AEA/CTA/NEA. It is likely that in the near future that you will receive emails at your work email addresses from the Freedom Foundation. They will encourage members to opt out of being a member of AEA (CTA/NEA) and paying dues. These emails will likely come from an address that appears as "Opt Out Today." Opt Out Today is part of the Freedom Foundation. This foundation has been accurately characterized in recent media reports as "door-to-door union-killers." They are corporate-funded lobbyists who support privatization of public schools. If you received their email, know that it is part of a campaign by a known anti-union group designed to weaken our union. They know we are stronger together."

When this happens, we need you, our members to fight back by:

- (1) Marking the Opt Out Today email as "spam" or "junk."
- (2) Clicking on the "Unsubscribe" link in the email. (If the unsubscribing process is difficult, or if you receive additional messages from Freedom Foundation after unsubscribing, please let us know.)
- (3) Forwarding the entire e-mail to Verve Mail (the Freedom Foundation's email provider) at support@vervemail.com, with the following text: The Freedom Foundation is spamming me and my coworkers. Please ask them to cease all spam emails

Please let Ken or Lori know if you or anyone you know receives an email from this organization so that we may alert the District that we are being spammed. District email is for District business.
