### ***Schools and Communities First Initiative***

CTA has backed the Schools and Communities First Initiative and needs help getting signatures to put it on the ballot. This initiative would correct proposition 13 by having business pay what they should be in property taxes. “CF closes a loophole in Proposition 13 to ensure that big corporations pay their fair share of property taxes to support public education and local community services. It raises up to \$11 billion for schools and communities every year and does NOT impact homeowners or renters. To be exact, \$4.5 billion of that is for schools and colleges. The early and large-scale organizing effort has already garnered more than 400 endorsements.” I’ve included talking points for you to share when you are talking to friends and colleagues. CTA would also like help with gathering signatures – when I get more information about how we can gather signatures I will pass it on. I will also forward you the email I received from CTA about this with links to help with a “10 minute meeting” with friends and colleagues and social media guidelines to help spread the word. Education could use this extra infusion and it does not impact homeowners or renters.
